**NOTICE TO EXHIBITORS:** No more than 10 entries allowed per envelope. No online entries will be accepted. Express mail entries must waive the signature requirement or they will be refused. Exhibitors are responsible for complete, accurate and legible information on their entry forms. Match Secretary assumes no responsibility for incorrect entry information due to illegibility of the entry. Entries will not be accepted without proper fees and signatures. Entries must be submitted on entry forms with the AKC agreement printed on the reverse side. Any entry not compliant with the above will be returned!

It is expressly understood that exhibitors alone are responsible for the behavior of their dogs and/or children. Any exhibitor whose dogs and/or children create unnecessary disturbances or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the Match Committee, be asked to leave the show site. In such cases, no refund of any fees paid will be made. Unsportsmanlike conduct, including rough handling or misconduct of any kind, will result in an excusal from the ring.

Notification of entry status will be emailed to all exhibitors providing an email address. Match Secretary is not responsible for emails returned due to illegible email addresses, full mailboxes, spam blockers or any other event causing email to be returned or missed, and no further effort will be made. Any exhibitor requiring to know their entry status before final confirmations are sent should send a SASE or postcard to be returned with that information. No other notification of entry status will be made. Final entry confirmations and judging schedules will be sent to all exhibitors after the final closing date, as per Chapter1, Section18 of the Regulations for Agility Trials. Exhibitors providing an email address will be emailed their confirmations. Exhibitors with no email address, or with email addresses that have bounced, their entry status will be sent with their confirmation via the US Postal Service.

**REFUNDS:** No refunds after the closing date will be allowed for bitches in season and injured dogs. Entry fees will not be refunded in the event that a dog is absent, excused, disqualified or barred from the competition by action of the Match Committee. No entry fees will be refunded if the match cannot open or be completed by reason of riots, civil disturbances, fire, act of God, public emergency, act of a public enemy, or any other cause beyond control of the organizing committee.

The owner/handler is solely responsible for having the dog ready at ringside when the class is to be judged.

Exhibitors should follow their veterinarians' recommendation to assure their dogs are free of internal and external parasites, any communicable diseases, and have appropriate vaccinations. Exhibitors and spectators are expected to keep the show grounds clean. Please pick up after your dogs and yourselves.

**CATALOGS:** Catalogs will be available by presale. If you would like a catalog, circle "Catalog" on your entry form and include \$10.00 in addition to your entry fees. A limited number of catalogs will be available the weekend of the match. Running orders will be available to all exhibitors at no charge.

**DOGS ELIGIBLE TO ENTER:** This match is open to all dogs 15 months of age or older that are registered with the American Kennel Club or that have AKC Limited Registration, Purebred Alternative Listing/Indefinite Listing Privileges (PAL/ILP), or an AKC Canine Partners listing number or approved Foundation Stock Service (FSS) breeds are eligible to participate. Dogs should be physically sound. Dogs that are blind or deaf shall not be eligible and neither are bitches in season, aggressive dogs, or dogs suffering from any deformity, injury, or illness which may affect the dog's physical or mental performance. Refer to Chapter 2 of the Registration and Discipline Rules for the listing of registerable breeds that may participate.

PRIZES AND AWARDS: Ribbons will not be awarded at this match.

**NEW Simplified Jump Height Card Process:** When filling out the entry form, there is a new section at the top of the form for exhibitors to designate whether your dog has a valid jump height card or if your dog needs to be measured. Please check the appropriate box so that the Match Secretary knows whether to include your dog on the Dogs To Be Measured List.

It is no longer required that you submit a copy of your dog's jump height card with your entry form or show it during day of show check-in.

**HEIGHT DIVISIONS:** Owners are responsible for entering the proper height divisions. Judges reserve the right to measure all dogs without a valid height card. Handlers may opt to run in a higher height division in the Regular program, but not in a lower division than their proper height division. Handlers must run in their proper height division in the Preferred program.

**CLASSES:** All Standard (inside) and Jumpers with Weaves (outdoors) classes will be offered. There will be no FAST, ISC or non-regular classes at this match. Electronic timers will be used at this event.

**COURSE FAMILIARIZATION:** Handlers are permitted to walk the course, without a dog, prior to the start of the class. A walk-through period will be held prior to each class following the judge's briefing. The walk-through may be split at the judge's discretion.

A warm-up area consisting of one regulation jump may be provided for exhibitors. The warm-up area is to be used exclusively for warming up the dog and not training or relieving of the dog.

**COLLARS:** At the handler's option the dog may wear a flat or rolled leather collar but there shall be no attachments hanging or otherwise on collars. Choke collars, pinch collars, electric and dummy collars, halties and gentle leaders are prohibited. Food, toys and whistles or other training devices are not allowed in the course area.

**SAFETY:** The safety of the dogs is our primary concern. By entering this match, exhibitors acknowledge that they are familiar with the rules and regulations of this sport, and that their dogs are familiar with and able to perform all the obstacles safely.




#### Directions to the site are as follows:

Dogs listed in the **AKC Canine Partners** <sup>SM</sup> program may be eligible to enter all-breed AKC agility trials at the club's option effective April 1, 2010. These dogs should be listed as All American Dog and must include their AKC number on the entry form and check the AKC No. box.


